

## Agreement on state and local taxation of foreign employees of public international organizations

Done: Washington April 21, 1992

Opened For Signature: This Agreement shall be opened for signature on the date it is signed by the Government of the United States of America and shall remain open for signature at Washington until June 1, 1992, by any international organization designated by the President of the United States of America as a public international organization pursuant to the authority granted in 22 U.S.C., subchapter XVIII.

Entry into Force: May 24, 1994

A. This Agreement shall enter into force when the United States and at least one of the Signatory Organizations, or international organizations that have acceded to the Agreement in accordance with Article 2(B), have notified each other that they have completed the procedures necessary to implement this Agreement as between them.

B. This Agreement shall enter into force with respect to each of the other Signatory Organizations or international organizations that have acceded to the Agreement in accordance with Article 2(S) on the date of the notification referred to in Article 3(A) or at such later time as that Organization notifies the Government of the United States of America that it has completed its necessary procedures.

Note: Article 2(B) states, "After June 1, 1992, any organization designated by the President of the United States of America as a public international organization pursuant to the authority granted in 22 U.S.C., subchapter XVIII, may, with the consent of the Government of the United States of America, accede to this Agreement by depositing an instrument of accession with the Government of the United States of America."
